LIMITED ONE YEAR WARRANTY

WARING warrants every new WARING PRODUCT to be free from defects in materials and workmanship for a period of one year from the date of purchase when used with foodstuffs, nonabrasive liquids (other than detergents) and nonabrasive semi-liquids, providing it has not been subject to loads in excess of the indicated rating.

Under this limited Manufacturer's warranty, Waring will repair or replace any part which is determined to be defective in materials or workmanship.

This limited one year warranty does not: a) apply to any product that has become worn, defective, damaged, or broken due to abuse, misuse, overloading, spillage, or tampering, or due to repairs or servicing by other than a Waring Approved Service Center; b) cover incidental or consequential damages of any kind.

The limited one year warranty is applicable only to appliances used in the United States and Canada; this supersedes all other expressed product warranty or guarantee statements.

For Waring products sold outside the U.S. and Canada, the warranty is the responsibility of the local importer or distributor.

This warranty may vary according to local regulations.

TERMS and CONDITIONS

All prices are net 30 days, rated firms. Interest at the rate 1½% per month will be charged on all past-due accounts. All shipments F.O.B. shipping point.

Freight prepaid and allowed on shipments of \$2,500 net or greater shipped to one location in the contiguous 48 states (exception pier deliveries) via least expensive way.

Freight prepaid and added to invoice on orders less than \$2,500.
Carrier will be designated by Waring.

All orders from customers, whether solicited and written by Waring sales representatives, distributors, dealers or end users, are deemed offerings to purchase until accepted by Waring in Connecticut. Waring reserves all rights to accept orders in whole or in part. Acceptance may be either by written confirmation or shipment of the order, in whole or in part.

FREIGHT DAMAGE IS NOT THE RESPONSIBILITY OF SELLER NOR DOES IT RELIEVE THE BUYER FROM OBLIGATION OF PROMPT PAYMENT.

Any claim for damaged merchandise must be processed through the delivering carrier by the consignee or the buyer.

RETURN MERCHANDISE WILL NOT BE ACCEPTED WITHOUT WRITTEN AUTHORIZATION.

All returned goods may be subject to a 20% restocking charge.
All returns must be authorized by the factory and have a Return Authorization (RA) number.
Any unauthorized returns will not be accepted.
