

# Waring Giveaway

## Official Rules and Regulations

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.**

The Giveaway titled **CB15 The Legend Custom America 250 Blender** (“Giveaway”) begins on June 29, 2026, at 11:00 AM EST and ends on July 4, 2026, at 11:59 PM EST (“Giveaway Period”). The computer clock of the Sponsor (defined below) is the official timekeeping device in the Giveaway. All questions, comments or complaints regarding the Giveaway should be directed to the Sponsor at the address listed below.

**1.
